## PRE-MEETING 6:30 & REGULAR MEETING 8:00 PM

COUNCIL PRESENT: JIM PORTER, DON GILLESPIE, JACK VARLEY, AL ATKINSON, JAMES MACHAJEWSKI, ED WIRKOWSKI, POLLY GRIMPE MAYOR VINCENT CINSKI ENGINEER PHIL HERMAN SOLICITOR MIKE WITHEREL

#### ABSENT:

- 1. JACK VARLEY ASKED IF WE COULD AFFORD TO GIVE A DONATION TO THE LIBRARY. POLLY GRIMPE STATED THAT THEY WERE REALLY LOOKING FOR LETTERS OF SUPPORT TO THE ORGANIZATIONS THAT THEY WERE WRITING FOR GRANTS. IT WAS AGREED 7/0 TO WRITE A LETTER OF SUPPORT AT THIS TIME AND LOOK AT FUNDING AT A LATER TIME.
- 2. THE BOROUGH MANAGER STATED THAT THE SKIDSTER CAME IN THIS WEEK WAS FINANCED THRU REAL LEASE AND THE CONFINE SPACE EQUIPMENT WILL BE IN SHORTLY. WILL BE SUBMITTING FOR \$33,000 FROM DEP FOR REIMBURSEMENT. MR. PORTER STATED THAT HE GAVE THE BOROUGH AN OLDER HARNESS.
- 3. MANAGER STATED THAT THE COUNTY TOLD US TO SUBMIT FULL APPLICATIONS FOR THE FOLLOWING CDBG APPLICATONS DEMOLITIONS, A PAVILION AT THE GAPP PARK AND REPAIR OF THE STREET AT NORTH AND LINCOLN AND NORTH AND GRANT WITH NEW ADA RAMPS.
- 4. DICK HADLEY FROM RESERVE TOWNSHIP ASKED IF WE WOULD BE INTERESTED IN GOING IN HALF FOR A USED WOOD CHIPPER. HE FOUND ONE IN GOOD CONDITION. IT WAS AGREED TO PURCHASE IT AS LONG AS WE WORK OUT AN AGREEMENT FOR REPAIRS, MAINTENANCE AND USAGE 7/0
- 5. DON GILLESPIE AND THE MANAGER TALKED ABOUT THE JUNK MEN COMING INTO TOWN AND TEARING PEOPLES GARBAGE APART, TAKING THINGS OFF OF PEOPLES PORCHES THAT ISN'T GARBAGE AND MAKING A MESS. IT WAS STATED THAT THEY COULD BE CITED FOR LITTERING AND TO SEE IF THE POLICE AND ROAD CREW COULD TALK TO THEM WHEN THEY SEE THEM. THEY PUT UP SIGNS ALL OVER TOWN AND IT WAS AGREED THAT WE SHOULD TAKE THEM DOWN.
- 6. THERE WAS A DISCUSSION ABOUT CATS RUNNING LOOSE AND DANGEROUS DOGS WALKING THRU TOWN. THE SOLICITOR WAS GOING TO TALK TO OTHER MUNICIPALITIES AND SEE WHAT THEY HAVE DONE . WE HAVE TRAPS HERE AT THE BOROUGH FOR WILD CATS AND THEY ARE GIVEN OUT FOR ANIMAL CONTROL.
- 7. WE HAVE TO PASS AN ORDINANCE TO CHANGE THE PARKING TICKET AND WE WILL HAVE TO DO AN ORDINANCE NEXT MONTH. MAYOR CINSKI ASKED IF COUNCIL WANTED TO REVISIT THIS ISSUE AND MAYBE CHANGE TO TWO HOUR PARKING, ELIMINATE METERS. THE BOROUGH MANAGER STATED THAT ETNA AND SHARPSBURG TICKETS START AT \$5.00. AFTER THE DISCUSSION IT WAS AGREED 7/0 TO GO THRU WITH THE INCREASE AND ORDER NEW TICKETS. 7/0
- 8. ELEMENT CHURCH ASKED IF THEY COULD USE OUR GAPP PARK ON JULY 15<sup>TH</sup> FOR A PERFORMANCE, THEY WOULD ALSO PERFORM AT THE BOYS AND GIRLS CLUB ON FRIDAY AND GIVE FREE FOOD AWAY ON SATURDAY. THEY ALSO ASKED IF THEY COULD USE THE GAPP PARK ON AUGUST 10<sup>TH</sup>, 11<sup>TH</sup>, 12<sup>TH</sup> AND 13<sup>TH</sup> FROM 5 TO 8 PM. THEY HAD THE SAME THING LAST YEAR AT THE BUTLER STREET LOTS. 7/0 AS LONG AS THEY CLEAN UP WHEN IT IS OVER.
- 9. THE BOROUGH MANAGER BROUGHT UP A NEW PROGRAM FROM THE COUNTY TO HELP WITH PURCHASING DRUGS THAT MAY NOT BE COVERED UNDER YOUR PLAN. WE HAVE COPIES HERE AT THE OFFICE AND WE WILL BE PUTTING IT ON OUR WEBSITE.
- 10. JIM PORTER MENTIONED THAT ROSE JESTAUDT WENT TO AN ALCOSAN MEETING AND THEY ARE STILL SAYING THEY ARE GOING TO TAKE OUR RIVERFRONT PARK PARKING LOT ADVISED THE MARINE TO SELL. THE SOLICITOR WAS GOING TO CHECK ON SOME THINGS FOR US.

THE JULY 13, 2010 REGULARLY SCHEDULED MEETING OF THE BOROUGH OF MILLVALE COUNCIL WAS CALLED TO ORDER AT THE BOROUGH COUNCIL CHAMBERS AT 8:00 PM BY PRESIDENT JIM PORTER, THE PLEDGE OF ALLEGIANCE WAS RECITED AND COUNCIL PRESIDENT ANNOUNCED THAT THE MEETING WAS BEING TAPED.

**ROLL CALL**: COUNCIL MEMBERS PRESENT – JIM PORTER, DON GILLESPIE, AL ATKINSON, JACK VARLEY, ED WIRKOWSKI, POLLY GRIMPE, JIM MACHAJEWSKI,

**OTHERS PRESENT**: MAYOR VINCENT CINSKI, CHIEF MILLER SOLICITOR MIKE WITHEREL, ENGINEER-PHIL HERMAN

SINCE EVERY MEMBER OF COUNCIL AND ALL BOROUGH OFFICIALS HAD AN OPPORTUNITY TO READ THE MINUTES OF THE JUNE 8. 2010 A MOTION WAS REQUESTED TO ACCEPT THOSE MINUTES WITHOUT CORRECTIONS, DELETIONS, ADDITIONS OR OBJECTIONS.

MOTION: DON GILLESPIE SECOND: JIM MACHAJEWSKI ROLL CALL VOTE: 6 YES-1 ABSTAIN ED WIRKOWSKI ABSENT FROM MEETING

## **PUBLIC COMMENTS:**

DARYL FESTA, 634 NORTH AVENUE WAS AT THE MEETING TO DISCUSS WHY HIS TENANT COULD NOT HAVE AN AUTO REPAIR SHOP IN HIS BUILDING ON NORTH AVENUE. HE STATED THAT HE RAN A BUSINESS OUT OF THERE FOR 10 YEARS HE WAS FLOODED TWICE AND PUT A LOT OF MONEY INTO HIS BUILDING. AFTER BEING VACANT FOR A YEAR HE FINALLY RENTED OUT AND THE BUSINESS LEFT DUE TO THE ECONOMY. NOW HE HAS RENTED THE BUILDING OUT FOR 25% LESS RENT AND THE BOROUGH IS HARASSING HIS TENANT TOLD HIM HE CAN'T OPERATE HIS BUSINESS OUT OF THERE AND HAS FINED ME \$376.00 ASKING ME TO TELL HIM TO LEAVE. WANDERING WHAT THE MOTIVATION WOULD BE FOR A BOROUGH WHERE IT IS AN UNDESIRABLE AREA WHERE FLOODING OCCURRED AND 40% OF THEIR BUSINESSES HAVE LEFT. WHEN HE HAS SOMEONE WHO PAYS HIS RENT, CLEANS THE SIDEWALK, KEEPS THE BUILDING CLEAN BRINGING IN TAX MONEY AND COMMERCE TO THE AREA. AND HAS A MECHANIC EMPLOYED WHO IS A BOROUGH RESIDENT. I HAVE BEEN FINED AND I AM WANDERING WHAT THE MOTIVATION IS. THE BOROUGH MANAGER STATED THAT WHEN HE CAME TO THE BOROUGH FOR A DETAILING SHOP YOUR PROPERTY WAS ZONED TRANSITIONAL WHICH IS NOT THE PROPER ZONING FOR A CAR REPAIR SHOP. THE BOROUGH GRANTED HIM A CONDITIONAL USE BASED ON THE FACT THAT HE WOULD ONLY BE CLEANING AND WASHING A VEHICLES ONE OR TWO CARS AT A TIME AT MOST. YOUR TENANT HAS STARTED TO DO OIL CHANGES, INSPECTIONS AND OTHER CAR REPAIRS THERE. WHEN YOU ORIGINALLY CAME TO US YOU AGREED THAT THIS WOULD NOT HAPPEN THAT IS WHY THE BOROUGH AGREED TO THE DETAIL SHOP NOT A CAR REPAIR BUSINESS. MR. FESTA STATED THAT HE FELT THIS WAS A RACIAL ISSUE AND HAS HAD NEIGHBORS TALK TO HIM ABOUT HIS TENANT. PRESIDENT OF COUNCIL STATED THAT HIS PERSONAL OPINION IS THAT HE CAME TO COUNCIL AND WE CHANGED OUR ORDINANCE WHEN HE ASKED US BUT HE DIDN'T COME TO US WHEN THIS GENTLEMEN CHANGED THE BUSINESS WITHOUT GETTING APPROVAL. WE HAVE HAD SEVERAL COMPLAINTS ON YOUR TENANT FROM STANDING ON THE STREET AND WAVING A SIGN OBSTRUCTING TRAFFIC. HE HAS TOLD OUR POLICE TO GET OFF OF THE PROPERTY. IN CONCLUSION MR. FESTA FELT THAT THE BOROUGH SHOULD ACCEPT ANY BUSINESS THAT WANTS TO COME IN THE BOROUGH AND NOT HAVE ANY RESTRICTIONS. OUR SOLICITOR HAS A BUILDING IN ROSS TOWNSHIP AND IT HAS BEEN EMPTY FOR TWO YEARS. HE WOULD HAVE TO ASK ROSS IF HE WANTS TO CHANGE THE ZONING. IF ANYONE WANTS TO CHANGE THE ZONE THEY NEED TO COME TO THE BOROUGH AND REQUEST A ZONING CHANGE.
