- 4. THE BOROUGH MANAGER ATTENDED THE BLIGHT SUMMIT PUT ON BY DOM COSTA SHE STATED THAT IT WAS A VERY GOOD SEMINAR AND A LOT OF NEW TOOLS ARE BEING GIVEN TO MUNICIPALITIES TO REMOVE SOME OF THE ABANDONED PROPERTIES.
