PRE- MEETING MINUTES STARTED 7:00 P.M.

ALL COUNCIL MEMBERS PRESENT

- 1. DISCUSSION ON WHETHER TO HIRE METER PERSON OR USE PART-TIME POLICE OFFICER TO PATROL THE METERS. CHIEF MILLER RECOMMENDED THAT WE USE THE PART-TIME OFFICER. VOTE WAS 7/0 FOR PART-TIME OFFICER TO PATROL METERS.
- 2. DISCUSSED BID RESULTS ON WATER LINE. MUCH HIGHER THAN EXPECTED. IT WAS DECIDED TO NOT AWARD THE BID AT THIS TIME AND WAIT UNTIL THE GROSSMAN LANE BID IS RECEIVED TO DETERMINE IF WITHIN OUR BUDGET. POSSIBLY DO JUST ONE OF THE PROJECTS DEPENDING ON GROSSMAN BID.
- 3. JACK VARLEY WANTED TO TALK ABOUT CHANGING THE ZONING FOR RESIDENTIAL PARKING LOTS. DISCUSSION TOOK PLACE AND THE DECISION WAS 7/0 TO GIVE ALL A COPY OF ZONING ORDINANCE FOR EVERYONE TO MAKE WHAT CHANGES THEY THOUGHT WERE NEEDED.
- 4. BOROUGH ENGINEER GAVE A QUOTE ON MARYLAND AVENUE OF \$9,200.00 TO TAKE IT DOWN. OWNER WAS LOCATED BUT HE TOOK EARLY RETIREMENT AND CAN'T AFFORD DEMOLITION COST. HE SAID WE COULD TAKE HIM TO MAGISTRATE AND HE WILL MAKE PAYMENTS ON IT. DUE TO DANGEROUS SITUATION A MOTION WAS MADE BY ANGELINA YOUNG AND SECONDED BY AL ATKINSON TO DEMOLISH THE HOUSE. FINAL VOTE WAS 7/0.

 RECEIVED A LOWER QUOTE FROM AMERIHEALTH CASUALITY FOR ABOUT \$2,000 DOLLARS LESS THAN STATE WORKMENS, SO WE SWITCHED COMP CARRIERS. IT WAS VOTED ON TO PURCHASE THE POLICE OFFICERS' LUNG AND HEART INSURANCE AT A PRICE OF \$2,909.00. A MOTION WAS MADE BY JACK VARLEY AND DON GILLESPIE SECONDED IT. IT WAS A 7/0 VOTE.
- 5. DISCUSSION ON MR. SMALL'S LEASE. IT WAS DECIDED THAT HE MUST PAY THE MONTHLY RENTAL ALL YEAR ROUND. IT WAS VOTED UNANIMOUSLY TO REPAIR SIX FIRE HYDRANTS. NO VOTE WAS TAKEN UNTIL NEW LEASE IS GIVEN TO MR. SMALL'S. BOROUGH MANAGER STATED THAT ROAD SALT CAME BID INCREASED FROM \$40.00 A TON TO \$104.00 A TON. STILL WORKING WITH COG TO GET LOWER PRICES BUT THERE IS A SHORTAGE IN SALT AND A NUMBER OF MUNICIPALITIES ARE NOT GETTING QUOTES AT ALL. BOROUGH MANAGER MIGHT HAVE TO ACCEPT A BID BETWEEN MEETINGS.
- 6. COG CABLE TV COMMITTEE MET AND AGREED THAT IT'S BEST FOR MUNICIPALITIES TO HIRE DAN COHEN TO NEGOTIATE CONTRACT FOR US AT A JOINT PRICE.
- 7. CODE.SYSTEMS PROPOSED TO CHANGE OUR BUILDING PERMIT. A COPY OF THEIR PROPOSAL WAS GIVEN TO ALL COUNCIL MEMBERS AND IT WAS DECIDED TO HAVE EVERYONE LOOK OVER THE PROPOSAL AND DISCUSS AT THE NEXT MEETING.
- 8. BOROUGH MANAGER GAVE A REPORT ON PENSION PLANS AND AT THIS TIME THEY STILL SEEM TO BE SOUND. IT WAS MENTIONED THAT WE COULD GIVE POLICE RETIREES A COST OF LIVING RAISE. BOROUGH MANAGER WILL LOOK INTO THE COST OF LIVING RAISE.
- 9. DISCUSSED THE LIGHTS AT RIVERFRONT PARK BEING OUT AND LOOKING INTO DIFFERENT TYPE OF LIGHT THAT ISN'T SO EASILY VANDALIZED. CHIEF MILLER STATED THAT POSSIBLY HE COULD GET A GRANT FROM ZAPALLA'S OFFICE TO PUT CAMERAS UP AT THE PARK. HE WILL LOOK INTO THAT.
