Public Works Department News

With fall now here, we ask that owners of trees please clean up the leaf litter from your tree as they tend to gather around storm sewer inlets and impede access for water drainage in that area. And as we know, winter is just around the corner.

Remember, it is illegal to shovel or blow snow onto borough streets. Keep storm sewer inlets free and clear from snow blockage. Water can back up onto the street which will cause frozen conditions to occur on the street. Please remember it is the residents' responsibility to keep their sidewalk clear and passable.

You will notice salt bins placed throughout the borough, these are for emergency use only. They are placed there for when cars are stuck, not for personal use for clearing sidewalks.

When shoveling snow, please remember to not block the fire hydrants. Packed snow around a fire hydrant makes it impossible to utilize the hydrant. As an added assist to the fire crews, when every second counts, keep a three foot clearance shoveled around a fire hydrant. This provides the quickest access for the volunteer firefighters.

CHANGES COMING TO YOUR PWSA BILL

Effective January 1, 2018 the Pittsburgh Water and Sewer Authority will no longer bill for ALCOSAN, Girty's Run or refuse for Millvale. The Borough of Millvale has engaged the services of Jordan Tax Service to bill and collect for these services. The last combined bill you will receive from PWSA will be in December. Beginning in January, your PWSA bill will only reflect your water usage. A separate bill will be sent to you from Jordan Tax Service for sewage charges calculated by your water usage and refuse. All billing questions regarding your sewage and refuse bill should be directed to Jordan Tax Service. Call JTS at 412-835-5243 option 4 or sewage@jordantax.com.

WHAT DO THOSE INITIALS MEAN?

ALCOSAN is the Allegheny County Sanitary Authority. ALCOSAN serves as the sewage treatment facility for the Borough of Millvale. For those residents who qualify, they offer a \$30 credit every three months to qualifying low-income homeowners and to tenants who have accounts in their own names for water or sewage service. To be eligible, applicants must be served by ALCOSAN and meet the family income limits set by the federal government. To apply please contact NHCO – Millvale at 416 Lincoln Avenue, Pittsburgh, PA 15209 or call 412-408-3830.

GRJSA is the Giry's Run Joint Sewer Authority. GRJSA serves as sewage conveyance for the Borough of Millvale. The authority was established in June 1984 as a joint municipal authority which includes Millvale Borough, Ross Township, Shaler Township, and Reserve Township. The purpose of the GRJSA is to manage the sewer conveyance system within the Girty's Run watershed.

PWSA is the Pittsburgh Water and Sewer Authority which owns, maintains and provides water services to the residents of Millvale. PWSA is also working to assist qualifying low-income customers to prevent water shut offs. They are currently working to develop a program. Customers can call 412-255-2423 to inquire how to apply.

PROPERTY TAX RENT REBATE

If you are not aware, Governor Wolf has extended the 2016 Property Tax Rent Rebate Program until December 31, 2017. Home owners or renters that have not filed may be eligible for a rebate if your annual income does not exceed \$35,000 as a homeowner or \$15,000 as a renter. The program benefits eligible Pennsylvanians age 65 and older; widows and widowers age 50 and older; and people that are 100% disabled ages 18 and older. Applications are available at our office.

LOW INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP)

The Low Income Home Energy Assistance Program (LIHEAP) will reopen November 1, 2017. It helps keep families safe and healthy through initiatives that assist families with energy costs. The Low Income Home Energy Assistance Program (LIHEAP) helps low income families pay their heating bills. LIHEAP is a grant. You do not have to repay it. The 2017-2018 income guidelines are \$18,090 for a single household and for each additional person add \$6,270. If you have received assistance in the past look for your application that should be coming soon or if you think you may qualify but are not sure contact our office for assistance.

DO NOT CALL LIST

I am often asked how to be added to the DO NOT CALL LIST. It is strongly recommended that you contact the National Registry at 1-888-382-1222 and the State Registry at 1-888-777-3406. You may need to register more than once if you enter a contest or sign up for a promotion as this cancels your Do Not Call registration with that business since authorization to call you was given and a business relationship has commenced. There are also exceptions to the Do Not Call law as it allows politicians, charitable organizations, and entities with whom there is a business relationship to be able to place calls to your phone number. However, consumers can revoke or cancel the business relationship by requesting placement on the business' internal Do Not Call List. Also it is recommended that all adults in a household individually register under Do Not Call, even though they will be listing the same home phone number.

Police Department News

As the holiday season approaches, I want to remind our citizens that there are some holiday grinches out there. Please take time to lock all of your vehicles and keep any packages off of your seats or in view on the floor of your vehicles. Take the time to secure packages in the trunk of your vehicles or cover items on the floor. Thieves always look for the easiest target so if something of value is not in view they will move onto an easier target. Take time to be sure the doors and windows are locked at home. If you are having packages delivered at your home keep track of when the package is supposed to be delivered. If the package is not at your door when it is marked delivered call 911 and file a report. If you wait too long to report possible thefts, it lessens the chance of recovering your property.

You may also experience phone scam type calls around the holidays. Do not give any of your personal information to anyone on the phone. If anyone claims to be a government agency and requests any type of payment or your personal information it is a scam. Hang up the phone and report the call to the officer on duty via 911.

I receive inquiries about seeing officers walking throughout our town. I require each officer to walk for one hour of their shift. There is not necessarily a problem in the area when you see them; they are just being proactive. I want our officers to interact with our citizens and business owners in the borough so please take a moment to speak with the officers when you see them. When I was growing up in Millvale, we knew each of the Millvale police officers by name and that is my goal now. They are your police officers; they serve you, the residents of Millvale, so take time to introduce yourself. A Millvale police officer visits the Millvale Community Library twice a week and the Millvale Boys and Girls Club once a week. The goal to this is that we want all children to be comfortable approaching a police officer, not fearing them. Please encourage your children to speak to a uniformed police officer even just to say hello.

In the Borough

Code Enforcement RESIDENT RESPONSIBILITIES

With the winter season approaching, remember that snow and ice must be removed within 48 hours. Ordinance No. 2571 requires property owners and tenants to maintain their sidewalks year round.

A reminder to those residents who live on Evergreen Avenue, if you have sidewalks on North Avenue, you are required to maintain those as well. Additionally, any sidewalk repair requires a permit under this ordinance.

Rental property owners are required to have their rental units inspected every three years. Property owners are required to notify the Borough when tenants change. To schedule an inspection, please call the Code Officer at 412-821-2777. Occupancy permits are also available online.

Zoning permits are required for any property improvement. Applications are available in the office or online. A complete zoning ordinance is available on the website at www.millvalepa.com.

For new businesses looking to open in the Borough, a zoning permit application is required to be approved before the business opens.

Residential trash pickup is on Friday, and trash may only be placed out no earlier than 5:00 p.m. the night before. Trash must be in sealed bags AND placed in a container with a secured lid in place. Placing trash out any earlier or not in secured containers may result in fines.

Millvale EcoDistrict

Our community is growing, and your voice has a big impact on how our community changes. We are always looking to learn and understand how Millvale can reflect the vision community members have.

This past summer, the Millvale Library coordinated the Millvale Community Needs Assessment; a comprehensive survey, mapping the hopes, needs, and dreams of Millvalians. With nearly a third of all households having responded to the survey, the Library is developing a report, to be released in the Spring of 2018, and will host public meetings to continue steering Millvale in the direction the community wants to see it go.

This past fall, thanks to a partnership with CMU's School of Architecture, six Millvale students participated in a camp, learning the basics of community design. The students then worked with a team to develop their own vision to make a safer connection to our Riverfront Park. The students presented their ideas at the old Millvale Moose on November 18th in front of community members, designers, and their families. This is one of the ways we are working to make everyone, including our youth, feel as though they have a voice in how our community grows in the future.



Ordinances To Remember

New Borough ordinances have been passed regarding permitting and flood zones. Please remember to contact the Borough before starting any project to obtain the proper permits.

Ordinance No. 2571, Sidewalk Ordinance, regulates the care and maintenance of sidewalks within the borough.

Ordinance No. 2566, Floodplain Ordinance, regulates the construction and development in the floodplain. All property improvements in the Floodplain require a Floodplain permit.

Ordinance No. 2576, Zoning Ordinance, regulates how zones can be used and for what purposes, and also regulates lot size, placement, bulk and the height of structures.

Failure to obtain any type of permit will result in work stoppage until all permit requirements are met. Please contact the Borough office at 412-821-2777 prior to beginning any project to determine which permits are needed. All improvements will require a zoning permit. As we prepare to turn the page on another year, the Millvale Community Development Corporation fondly looks back on 2017 which will be remembered as a year of development for the MCDC, in terms of revitalization and purpose.

524 Grant Avenue is complete and Tazza D'Oro Café and Espresso Bar is open. In Italian, Tazza D'Oro means "cup of gold". Their coffee is roasted by Counter Culture Coffee, and baristi are trained through an extensive training and a professional certification program, learning crucial skills in dedication to the fine art of crafting delicious coffee and espresso beverages. They purchase and carefully prepare some of the finest coffee available, sourcing food and milk from local, independent vendors and farms. Additionally, Tazza D'Oro will have office space at 524 along with a training facility in partnership with Counter Culture Coffee.

Right down the street, at the MCDC-owned 220 North Avenue, we welcome Ton Pottery. Ton Pottery is a ceramics teaching studio, which offers adult and children's classes in hand building and wheel throwing, along with workshops, baby and me time for parents of young children and open studio time for the more advanced student. Ton Pottery will also feature a small retail shop featuring a few choice potters from the Western Pennsylvania area.

Across the street on North Avenue, we also welcomed Bar 3 and Shining Light Prenatal Education Center. The revitalization of Millvale spread beyond Grant and North Avenues in 2017 as Millvale embraced the opening of Lumberjaxes, Eichenlaub, the Millvale Moose with New Sun Rising, Tres Rios Sports and Three Rivers Tattoo. Apologizes to any new businesses we did not name but welcome!

Millvale Studios at 216 North Avenue experienced a fire which has temporarily closed the building. The MCDC is excited to begin rebuilding the Studios in 2018.

The Business Association of Millvale (BAM) continues to grow and offer tremendously successful events including May Days, Halloween Trick r Treat and the upcoming Yuletide Celebration and Tree Lighting. BAM also offers businesses a chance to meet on a regular basis and combine resources to attract shoppers to Millvale.
