Pennsylvania State Women's Golden Gloves Champion

Millvale Council would like to recognize resident Colleen Davis for her outstanding achievement in women's boxing. The twenty-six-year-old Millvale resident started boxing in high school for exercise. Three years ago, she decided to start boxing competitively and hasn't stopped yet. Colleen has won back-to-back Western Pennsylvania Golden Gloves Championships, and is currently the Pennsylvania State Women's Golden Gloves Champion for her class (141 lb. elite Class). Colleen trains under former professional Jose Carballo from the Ray Schafer Boxing Association located in Sharpsburg.

Colleen is currently ranked #8 in the country by USA Boxing which is the governing body for the Unites States Olympic team. She is focused on making the 2020 Tokyo Olympic team. In order to be considered for the team she must be a ranked fighter and they will review who she has fought. They are looking for matches with nationally ranked boxers. Colleen had an extremely close loss to the National Golden Gloves champion in her division in July. How it happens:

If not disposed of properly, pet waste left on streets, pavement, yards, and driveways can be picked up by stormwater runoff and carried into storm drains and nearby water sources. Pet waste can cause significant stormwater pollution and present health risks like infections from disease-causing bacteria and parasites.

Steps for prevention:

There are three simple ways to prevent pet waste from compromising our water quality.

- 1. Use a bag to clean up the waste.
- 2. Dispose of the waste in the trash.
 - 3. Tell others to do the same.

Halloween Safety: Remember to do the following when dressing the kids for Halloween:

- Keep candles and jack-o-lanterns away from areas where children can brush against them.
- Avoid baggy or oversized costumes to prevent contact with candles or open flame.
- Use costumes made with flameresistant fabrics.

Police Department/Mayor's Note

Summer is upon us, and along with the great weather brings increased foot and bicycle traffic and especially children on bikes. Please be aware of all of the traffic, slow your speed down and obey all speed limits, traffic lights and signs. Millvale Police will be out enforcing the traffic laws; we do not want to write costly citations but will in order to keep our residents safe.

I receive information almost every week about suspicious activity observed by our residents and business owners. Please call me and I will return your call and speak to you about your concerns. There is no problem too small or too big that Millvale Police can't address. Most of the time it is something we can solve quickly but in the case it ends up to be more involved, the sooner we know the better. If there is an incident that is happening at the time, please call 911. If you want to speak with an officer, just advise the 911 Dispatcher that you would like to speak to a Millvale Borough police officer. We respond to every call for service dispatched.

In Millvale, like in every community large or small across our country, we have an opioid addiction problem. This is not unique to Millvale; this epidemic affects every socio-economic category regardless of sex, race or ethnicity. If you or a loved one are addicted, understand that addiction is a disease and it must be fought as a disease.

Many of the overdose cases we are now seeing is not just from heroin, but from fentanyl, which in some cases can be more harmful. Some of the new strains of this drug are so potent that the drug we use to combat heroin (Narcan) does not work or several doses of Narcan can be required. Do not hesitate to call 911 immediately if you encounter someone overdosing. Every minute counts towards saving their life.

All Millvale police officers are certified in administering Narcan, and we carry the drug in every police car. If someone in your home is struggling with this disease, you can purchase Narcan over the counter and keep it in your home. There are no real side effects, and it may be the difference between life and death. If you are struggling with this addiction, never stop attempting to quit; you may fail many times before succeeding, just do not give up in your attempts.

A message to those persons in our community that wish to sell this poison to our residents. You have no safe haven in our town. In the past few weeks I have met with other law enforcement agencies and we are now actively partnering with narcotic task forces from the county, state and federal level. If we receive information of an individual or a location in our town dealing this poison, you can be assured you are being watched. I will make sure every asset available will be used to remove those involved with selling this poison from our community. Drug dealers are not welcome here. We have both uniformed and non-uniformed officers working daily to find you and remove you. I look forward to meeting each and every person in our community selling this poison!

On another note, please be aware that residents cannot save parking spots with chairs or other items. We will be removing these items in the coming days. We will first place a note on the item and place it on the sidewalk, but if it continues we will remove the item used. I work Monday through Friday 8 a.m. to 4 p.m. and am always available to any member of our community.

Code Enforcement

With summer in full swing, please remember to cut your grass and maintain the weeds. Also remember that you are responsible for maintaining the weeds on your sidewalk per Ordinance # 2537.

Rental property owners are required to have their rental units inspected every three years. Property owners are required to notify the Borough when tenants change. To schedule an inspection, please call the code enforcement officer at 412-821-2777x3135.

Zoning permits are required for any property imporvement. Also, you must fill out a building permit application. Applications are available in the office or on our website at www.millvalepa.com.

The Borough of Millvale has updated its zoning ordinance. A complete version is available on our website for your review. For new businesses looking to open in the borough, a zoning permit application is required to be approved before the business opens.

Residential trash pick-up is on Friday, and trash may only be placed outside at 5:00 p.m. the night before. Trash must be in sealed bags and placed in a container with a secured lid in place. Placing trash out any earlier or not in secured containers will result in fines.

To dispose of televisions or computer monitors, please contact At Your Door Special Collection at 1-800-449-7587 to schedule a pick-up. Waste Management is not able to pick up these items on regular trash days.

Ordinances To Remember

New Borough ordinances have been passed regarding permitting and flood zones. Please remember to contact the Borough before starting any project to obtain the proper permits.

Ordinance No. 2571, Sidewalk Ordinance, regulates the care and maintenance of sidewalks within the borough.

Ordinance No. 2566, Floodplain Ordinance, regulates the construction and development in the floodplain. All property improvements in the Floodplain require a Floodplain Permit.

Ordinance No. 2576, Zoning Ordinance, regulates how zones can be used and for what purposes, and also regulates lot size, placement, bulk and the height of structures.

Failure to obtain any type of permit will result in work stoppage until all permit requirements are met. Please contact the Borough office at 412-821-2777 prior to beginning any project to determine which permits are needed. All improvements will require a Zoning Permit.
