BUSINESS WAYFINDING SIGN PROGRAM

WHAT IS A WAYFINDING SIGN? THEY ARE THE BLUE SIGNS WITH BUSINESS NAMES HANGING FROM LIGHT POLES IN THE MAIN BUSINESS DISTRICT. ORIGINALLY THE SIGNS WERE PURCHASED FOR MILLVALE MAINSTREET BUSINESSES AS PART OF THE HOMETOWN STREETS GRANT IN 2009.

WHY DO WE NEED THIS PROGRAM? TO CREATE AND ASSURE A UNIFORM SIGNAGE PROGRAM, TO ALLOW NEW BUSINESSES TO HAVE ACCESS TO SIGNAGE.

HOW DOES THE PROGRAM WORK? THE BOROUGH AIMS TO MAINTAIN AND UPDATE THE BUSINESS WAYFINDING SIGNS TO MILLVALE BUSINESSES WITHIN THE ESTABLISHED MAINSTREET DISTRICT (GRANT, LINCOLN, NORTH THROUGH 300 BLOCK AND ALL STREETS INTERSECTING).

BOROUGH PLANNING AND ZONING WILL APPROVE ALL WAYFINDING SIGNAGE REQUESTS AND SCHEDULE INSTALLATION.

MILLVALE BOROUGH PUBLIC WORKS WILL INSTALL SIGNS SEMI-ANNUALLY AS THEIR OTHER TASKS ALLOW AND ALIGN WITH OTHER LIGHT POLE PROJECTS SUCH AS FLAG MAINTENANCE, BANNER HANGING, AND HOLIDAY DECORATIONS.

BY COMPLETING AND SUBMITTING THIS APPLICATION FOR APPROVAL I HEREBY STATE THE FOLLOWING

- I AGREE THAT THE BOROUGH OF MILLVALE RETAINS THE RIGHT TO REMOVE THE SIGN AT ANY TIME.
